



Blacksmith shop, Dr. Thes. Coke Glover's Drugstore + office, original location of Woodell house, + Beavers house on N side of Courthouse Aquare The first courthouse was built on the town square around the same time and served the county until 1870 when the county seat moved to Fairburn.

Robert Cook purchased the building for \$64.50 in 1914, dismantled it, and used the materials to construct barns on his farm.



Campbellton Town Square Landmarks

The John S. Beaver house, located on the town square adjacent to the original courthouse, was one of the first residences built in Campbellton (@ 1826-1828).

By an act of the General Assembly, dated December 20, 1828, the Superior and Inferior Courts, as well as elections, were to be held in the Beaver House until a permanent courthouse could be constructed.



The Latham plantation home was once located near the present day intersection of Hwy 92 and Cascade Palmetto Hwy.

The home was built in the 1830s by Colonel Thomas Latham, a charter member of Campbellton Lodge, and former Solicitor General of the Coweta Judicial Circuit, and a State Legislator.



Campbellton Baptist church was originally constructed in 1828 on Cochran Rd beside the Beavers House. At some point, the original church burned and was rebuilt on church Street directly across the street from the original courthouse.

The Old Campbellton Baptist historic cemetery is located at the original site to the right of the Beavers House.



Campbellton Methodist Church, located behind the Masonic Lodge on Campbellton Fairburn Road, was founded in 1830.

The church cemetery is the final resting place of numerous un-named Confederate and Union soldiers that died in battles in and around Campbellton during the summer of 1864.



Campbellton Lodge No. 76, F&AM was chartered on November 1, 1848, by the Grand Lodge of Georgia.

Accounts suggest the building was constructed in late 1847 or early 1848.

The Lodge is still in use today, holding the distinction of the oldest Lodge still meeting in the same building in Georgia!!





Dr. Glover was active in county politics. He was one of two delegates to the secession convention when Georgia left the Union and joined the Confederacy. This building is titled Dr. Glover's medial Office.

He was also a charter member of Campbellton Lodge.

The Campbellton Bridge Company was incorporated to build a bridge across the river at Campbellton. It was over one hundred years before a bridge.
